

ADVERTISEMENT FOR BIDS

Sealed bids will be received for the Water, Sanitary Sewer, Storm Drainage and Street Improvements, CDBG No. 08p-x-138-2-5076 in the Vidalia City Hall, until 11:00 AM (Local Time), August 18, 2009, at which time they will be publicly opened and read.

The work under this Contract will consist generally of the following:

The construction of ± 0.56 miles of leveling and resurfacing, ± 5938 LF of concrete gutter with raised edge, ± 2035 LF of RCP storm drain pipe, ± 29 drop inlets, ± 2 storm sewer manholes, ± 2 drain inlets, ± 1 junction box, ± 2709 LF of 6" watermain, ± 12 MJ gate valves, ± 6 fire hydrants, ± 27 transfer of service, ± 402 LF of 8" sanitary sewer, and all appurtenances necessary for a complete job.

All work on the Project must be completed within 180 consecutive calendar days of date of notice to proceed.

Bid shall be submitted on Bid Proposal Forms furnished for that purpose, in accordance with the Contract Documents and the Plans and Specifications which are on file and may be reviewed at the office of the City Manager and the office of Hofstadter and Associates, Inc., Consulting Engineers, 4571 Arkwright Road, Macon, Georgia 31210.

No bid will be considered unless sealed and filed with the City of Vidalia prior to the time set forth above, and accompanied by a Bidder's Bond, payable to Vidalia, Georgia, for 10 percent of the amount of the bid; to be forfeited as liquidated damages in the event that the bid be accepted and the bidder fail to enter promptly into a written contract and furnish the required Payment Bond and Performance Bond and Insurance Certificates. Bids arriving after the designated time will be returned unopened.

No bids shall be withdrawn for a period of 60 days after the opening of bids. City of Vidalia reserves the right to reject any or all bids and to overlook and/or disregard informalities or irregularities in the proposals.
